Introduction

("SBS"), a company authorized and regulated by the Swiss Financial Market Supervisory Authority FINMA, registration Number CHE-106.787.764, with its registered office at The Circle 38, 8058 Zurich Airport, Switzerland. SBS is a wholly owned subsidiary of Saxo Bank A/S, a Danish regulated bank, headquartered in Copenhagen.
